Reporting to the Prevention Services Supervisor, the Prevention Services Worker is responsible for providing prevention services support to children, youth and families who are identified at risk. The Prevention Services Worker will participate in case planning and wrap around service delivery to children, youth, and families. This position functions as a member of the Circle of Care supporting children, youth, and families.

##### **Minimum Education & Experience**

- Child & Youth Worker or Social Services Diploma
- Two (2) years of direct experience in a Social Services Agency would be an asset.

- Respect for, sensitivity towards as well as knowledge and understanding of Anishinabek culture, traditions, and the Seven Grandfather Teachings
- Basic knowledge of the Child, Youth and Family Services Act
- Knowledge of First Nation service delivery, customs, and traditions in responding to child welfare
- Knowledge of traditional practices, ceremonies, and teachings
- Knowledge of Niijaansinaanik Child and Family Services programs and services

##### **Other Requirements**

- Provide a clear Police Records Check with Vulnerable Sector Check
- Provide a Class 'G' Ontario Driver's Licence, have access to a vehicle and ability to travel
- Have \$1M auto insurance liability coverage
- Provide three-year uncertified Driver's Abstract
