Reporting to the After Hours Supervisor, the After-Hours Service Worker is responsible for providing after-hours and weekend crisis services, responding to allegations of child maltreatment, and providing immediate protective services when required. The After-Hours Service Worker's role is to defuse crises and stabilize events that occur outside of regular Agency hours until cases can be assumed by regular day staff.

Minimum Education

- Respect for sensitivity towards as well as knowledge and understanding of Anishinabek culture, traditions and the Seven Grandfather teachings
- Knowledge of the First Nation service delivery, customs and traditions in responding to child welfare
- Knowledge of traditional practices, ceremonies and teachings

- Must provide a clear Police Records Check with Vulnerable Sector Check
- Must have a Class 'G' Ontario Driver's Licence, access to a vehicle and the ability to travel
- Must have \$1M automobile insurance
- Must provide a three-year uncertified drivers abstract
